The annual report contains Clear Day Treatment's achievements and highlights for 2023. We are proud to announce that in 2023 we served 1,123 patients, which is a decrease over the 1,146 patients we served in 2022. In 2023, we provided over 15,000 hours of group counseling in our residential program, while implementing ASAM Alignment into our program. Clear Day Treatment collected an array of innovative data from the EHR installed in 2020. We continued to improve with our PointClickCare software to optimize patient care.

## 2023 CDT HIGHLIGHTS

- Clear Day Treatment served 1123 patients in 2023
  - 437 detox patients
  - 657 rehab patients
  - 728 male patients
  - 392 female patients
  - 3 “undefined” patients
  - 9 pregnant females
- Served 28 African American patients
- Served 3 Hispanic or Latino patients
- Served 202 Caucasian patients
- Served 892 “undefined” patients

Clear Day Treatment staff provided more than 15,000 hours of group counseling in 2023.

Most staff were trained in Motivational Interviewing, De-escalation/Conflict Resolution, and Ethics and Boundaries.

Implemented Medication Technicians and a Medical Assistant on self-medication observation and documentation.

Clear Day Treatment counselors worked and continued to work with the team from IRETA on becoming and maintaining ASAM alignment.
